

Colonel Howard J. Killian, Commander, U.S. Army Garrison, Hawaii, was the installing officer at our installation luncheon on Thursday, January 26, 2006, at the Hale Ikena, Fort Shafter. The Executive Committee officers for 2006 are Vernon Von, President; Harold Kuwahara, Vice President; Gordon Cho, Secretary; and Art Yamamoto, Treasurer. Additionally, two members of the Board of Directors, Jack Bohman and Jerry Lesperance, were installed for another two-year term. Also recognized were the committee chairs for the coming year. They were Herbert Nakagawa, Fund Raising; Kelley Roberson, Govt/Legislative Affairs (unable to attend due to work commitments); Nari Hamlin, Historical Activities; Bob Kozuki, Personal Affairs; Harold Kuwahara, Programs; Mark Webster, Publications/Public Affairs (unable to attend due to work commitments); and Wes Fong, ROTC/Veteran Affairs. Congratulations to all for their willingness to serve.

Following this brief service, Col. Killian gave a very informative talk on the future of approximately 81,000 U.S. Army personnel in Hawaii. He spoke briefly on the arrival of a Stryker Brigade in February, the expenditure of 700-million dollars in construction projects on Oahu and the Pohakuloa Training Facility, the difficulty and ongoing controversy on the use of Makua Valley for live-action training, future troop deployment to the Middle East, the addition of 1,000 new homes for base housing by the end of 2007, and the scheduled opening of the new, improved Schofield Base Exchange on April 1, 2006. Col. Killian is a nuts-and-bolts, no-nonsense commander who holds many well earned ribbons and medals. He is a command pilot and maintenance test pilot for the UH-60 Black Hawk. We appreciate him taking time from his busy schedule to conduct our installation service and update us on the U.S. Army in the Pacific.

## Tax Tip

The **Survivor Benefit Plan annuity received by the survivor of a military retiree is taxable income on the Federal tax return.** The Hawaii State tax rules don't specifically address the taxability of a SBP annuity; however it does provide that a "military pension" is not taxed. Therefore, it is reasonable to conclude that the **State of Hawaii does not tax SBP annuities.**

## Pentagon Health Chief Defends Retiree Fee Increases

To their credit, Assistant Secretary of Defense (Health Affairs) Dr. William Winkenwerder and his principal deputy, Dr. Steve Jones, went out of their way to talk to military association representatives about why the Defense Department wants to double or triple TRICARE fees for retired beneficiaries. They came to Alexandria, Virginia to spend an hour with more than 50 representatives of The Military Coalition, including several from MOAA.

But it was a frustrating meeting on both sides, as Coalition members had lots of questions about the specifics of the new proposals that Winkenwerder said he couldn't yet answer. While MOAA and others have published summaries of the DoD plan received from multiple reliable sources, the official plan may not be released until the President submits his budget for FY07 later this month or in early February.

Pressed about whether published reports have been accurate, Winkenwerder chose his words carefully, saying, "I wouldn't want you to think that what you've seen is what will be done." While that might mean the Administration is doing some rethinking, it might also mean there is more to the plan. In that vein, MOAA has learned that the initiative also is likely to include a proposal to increase the "third tier" \$22 pharmacy co-payment and establish a new "fourth tier" of drugs for which the beneficiary would have to pay the full cost.

Barred from discussing details, Dr. Winkenwerder briefed the Coalition on why the Department feels the need to shift more costs to retirees. His principal points were:

\*Health costs are rising faster than the rest of the Defense budget, mainly because of legislated benefit expansions, increasing retiree use of care, and general health inflation

\*Retirees will consume 65% of defense health spending by 2011, vs. 43% in 2000 (mainly because of the enactment of TRICARE For Life in 2001).

\*There has been no change in retiree health fees since the military health benefit is "extremely rich," with military retirees averaging \$680 in out-of-pocket health costs a year, vs. \$3700 for retirees from civilian employers.

\*As private sector employers have cut back on health benefits, the percentage of retirees actually using TRICARE has risen from 66% in FY2002 to 78% for FY2006, and is expected to rise to 87% by 2011.

\*Limiting DoD health costs to the current 8% of the DoD budget would save \$20 billion a year by FY2015.

\*Pharmacy costs tripled from FY2001 to FY2006, due to enactment of pharmacy coverage for Medicare-eligible retirees in 2001.

When Dr. Winkenwerder solicited TMC comments, MOAA's Steve Strobridge said comparison of military vs. civilian health costs fails to consider some critical points. Military retirement benefits are the only offset provided for the unique and extraordinary demands inherent in a 20-30 year military career. Military retirees have paid far greater premiums than civilians; they just paid most of them in service and sacrifice rather than in cash. Further, he said the Pentagon should be asking Congress for a bigger defense budget to pay for the needed benefit improvements Congress has enacted rather than seeking to fund those other defense needs out of retirees' pockets.

## MOAA NATIONAL'S "GIVE ME 10" RECRUITMENT CAMPAIGN WRAP-UP

December 31, 2005 marked the final date for anyone desiring to participate in the MOAA National Headquarters "Give Me 10" recruitment campaign. The campaign was designed to increase membership with the national organization. Local chapter participation ensured opportunities for incentives that included: \$10 for each new paying member; \$100 bonus (one time) for first ten new paying members signed up; \$1000 prize for chapters that re-cruit the most new members--prizes awarded in categories based on chapter size.
