Drones in the USAF

After a sumptuous buffet luncheon at Hale Ikena, Ft. Shafter, on Friday, March 19th, forty Aloha Chapter members and two guests were treated to a very interesting presentation on Unmanned Aerial Vehicles (UAV), also known as drone airplanes, by LTCOL Jill Singleton, USAF, Commanding Officer of the 8th Intelligence Squadron, Hickam AFB.

Her squadron is one of the subordinate components of the 480th Intelligence, Surveillance and Reconnaissance Wing, headquartered at Langley AFB, VA, providing command and control for the timely processing, exploitation and dissemination of intelligence data for U.S. combatants across the globe. However, not only military operations in Iraq and Afghanistan are supported, but her squadron assisted in the recent relief operations in Haiti.



LTCOL Singleton said that the bulk of her unit's work is in support of the wars rather than the Pacific theater or humanitarian missions. Requests from the U.S. Central Command theater include everything from using a Predator UAV to observing a raid by U.S. soldiers to scanning convoy routes for roadside bombs. "Because we have so much going on, especially in the UAV video feeds, we're always looking at ways to more effectively use the limited personnel resources that we have," she said.

Ukulele Tour Rescheduled



and disseminate the intelligence data gleaned—such as maps showing houses visited by targeted insurgents or where certain vehicles stopped—to the commanders on site.

"We're always looking at exactly how many people it takes to do this work and how many feeds we can cover simultaneously," **Singleton** said. It is a challenge to keep up with the war zone's appetite for intelligence. The analysts also communicate directly with soldiers and joint terminal attack controllers, or JTAC's, on the ground via email or online chat software to find out what support they need and for the necessary further confirmation that the target is indeed hostile.

Unfortunately, there were glitches with the audio-visual setup, so LTCOL **Singleton** had to pass around her laptop to show scenes of sites photographed by the UAV's. The resolution was quite impressive.

LTCOL **Singleton** concluded her informative, unclassified talk with a brief question-andanswer session. **Mark**

Reassuring Statement from Eric K. Shinseki, GEN, USA, Retired, **Secretary of Veterans Affairs**

March 21, 2010

WASHINGTON - As Secretary of Veterans Affairs, I accepted the solemn responsibility to uphold our sacred trust with our nation's Veterans. Fears that Veterans health care and TRI-CARE will be undermined by the health reform legislation are unfounded. I am confident that the legislation being voted on today will provide the protections afforded our nation's Veterans and the health care they have earned through their service. The President and I stand firm in our commitment to those who serve and have served in our armed forces. We pledge to continue to provide the men and women in uniform and our Veterans the high quality health care they have earned.

President **Obama** has strongly supported Veterans and their needs, specifically health care needs, on every major issue for these past 14 months - advance appropriations, new GI Bill implementation, new Agent Orange presumptions for three additional diseases, new Gulf War Illness presumptions for nine additional diseases, and a 16% budget increase in 2010 for the Department of Veterans Affairs, that is the largest in over 30 years, and which has been followed by a 2011 VA budget request that increases that record budget by an additional 7.6%.

Keep Your Defense Enrollment Eligibility Reporting System (DEERS) Up To Date

Active-duty and retired service members are automatically registered in DEERS, but they must take action to register their family members and ensure they're correctly entered into the database. Mistakes in the DEERS database can cause problems with TRICARE claims, so it is critical to maintain your DEERS information.

You can verify your DEERS information by contacting your regional TRICARE managed care support contractor, your local TRICARE service center or the nearest uniformed services personnel office (ID card facility). Sponsors or registered family members may make address changes, however, only the sponsor can add or delete a family member from DEERS, and proper documents are required, such as a marriage certificate, divorce decree and/or birth certificate. Each family member's eligibility record must be updated separately when changes occur.

Any changes that impact you or your family (e.g., marriage, birth, divorce, death) need to be reported to DEERS so that eligibility can start or stop under DoD and Service guidance. To update your DEERS information:

- Visit your local uniformed services personnel office or contact the Defense Manpower Data Center Support Office (DSO) at 1-800-538-9552. You can find the nearest uniformed services personnel office at: http:// www.dmdc.osd.mil/rsl/.
- Fax address changes to DEERS at 1-831-655-8317.
- Mail the address change to the Defense Manpower Data Center Support Office, ATTN: COA, 400 Gigling Road, Seaside, CA 93955.
- Go online to TRICARE to update your information: http://www.tricare.osd.mil/deers/.



Look at the date above your name on the back page. If it doesn't say Life Member, that is your expiration date—when you need to renew your membership.




