## March Luncheon

On Friday, 24 April, only 16 members and guests attended our buffet luncheon at the Oahu Veterans' Center in spite of the distinguished guest speaker secured by our Program Chairman **Mike Fricano**. That was disheartening.



**Earnest Lau**, the Chief Engineer and manager of our Board of Water Supply (BWS), gave a very interesting and informative slide presentation of Oahu's vulnerable aquifer and aging water distribution system. Oahu fortunately has favorable geology with the Koolau mountains perpendicular to the trade winds to create the rainfall which then filters down to a vast underground reservoir. Stressing that "Water is Life," he reported on the chronology of the Red Hill fuel leak disaster that contaminated the water of 93,000 households, mostly Navy families, and the efforts to defuel the 24 huge tanks situated a mere 100 feet above our vital aquifer.

His talk ended with a lively question and answer session. 

## National Vietnam Veterans' Day

March 29<sup>th</sup>, the anniversary of the return of our defeated military in Vietnam, has been finally declared as our National Vietnam Veterans Day in recognition for the more than a decade of sacrifice that our military endured in Vietnam.

At 1000, Wednesday, 29 March, a Vietnam War Veterans Day Ceremony was held in the pouring rain at the Hawaii Veterans' Cemetery in Kaneohe. Thankfully, our chapter member **Rona Adams**, the President of the local Chapter 858 of the Vietnam Veterans of America, had made arrangements to have large awnings installed. She introduced the speakers.

LTG James Jarrad, Deputy Commanding General, US Army Pacific, was the keynote speaker

### **Urgent Request for DD-214 Discharge Papers & Separation Records**

*Source:* NPRC email 10 February 2023

If someone needs an Emergency Request for immediate issue of a replacement DD-214, like the sudden death of a former service member, the below link is what needs to be used to send an electronic request. They will send an email response to the email address you provide on the electronic request. This is different than submitting a typical request that requires filling out a SF-180 "Request Pertaining to Military Records" which is done via snail mail. While the snail mail request could take 3-5 weeks to get a response, I was told the Emergency Request should be received in 3-7 days.

To submit a request, you may do so online at <http://vetrecs.archives.gov>, and select the blue "Start Request Online" button.

1. On the VETERAN SERVICE DETAILS page, select Emergency Request as the Category.
  2. Select the nature of your request (Burial, Medical Emergency, Homeless Veteran) in the next box that opens.
  3. Include an email address for communication and possible digital delivery, and/or a FAX number, otherwise, the document(s) will be physically mailed to the address entered.
  4. If your request is for a burial, please ensure proof of death is uploaded. This could be a death certificate, funeral home letter signed by the director, or obituary.
- To avoid the necessity of submitting this urgent request, all veterans should make prior arrangements by having their DD-214 available.

## Vietnam Veterans

The Vietnam Era was one of the most turbulent times in American history, with the war abroad and mass civil unrest at home. As a result, Vietnam veterans returned to a homecoming unlike any generation of veterans before or since. Simply put, the "welcome home" wasn't always welcoming due to opposition toward the war.

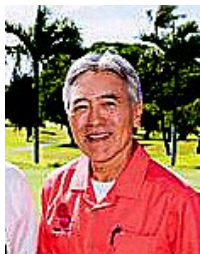
Nearly nine million Americans served during the Vietnam War Era, and as of the 2020 Census, they are the largest cohort of veterans in America, with an estimated 6.4 million living vets at a median age of 71. In honor of their service, here are a few important things to know about the Vietnam generation. Media and pop culture often like to portray Vietnam veterans as a generation of men sent over to fight a war they didn't understand against their will, but the reality is most of those who fought in Vietnam volunteered to be there. Of the 8.7 million troops who served in the Vietnam Era between 1964 to 1973, 3.4 million deployed to Southeast Asia and 2.7 million served in South Vietnam. Out of all the people on active duty at the time, only 2.2 million were drafted, and only 25% of the total number of troops in combat zones were drafted.

President Harry S Truman signed an executive order that integrated America's armed forces in 1948. Although the Korean War was fought between 1950 and 1953, the U.S. military was still experiencing growing pains with the new policy. By the time the United States began increasing its involvement in South Vietnam, American military units were fully integrated, with an estimated 340,000 African Americans, 80,000 Latinos, 42,000 Native Americans and 35,000 Asian Americans serving in Vietnam.

Not all Vietnam veterans made it back home; 2,646 Americans were unaccounted for at the end of the Vietnam War, in all theaters of operations. Since the end of the war and the repatriation of American prisoners of war in 1973, the Defense POW/MIA Accounting Agency has recovered or identified 1,062 of those. That means 1,584 U.S. service members are still waiting to come home. An estimated 30% of Vietnam veterans suffered from post-traumatic stress disorder during their lifetime, according to the 1988 National Vietnam Veterans Readjustment Study, the last time such a study was done. Still, 97% of Vietnam vets hold honorable discharges, and the unemployment rate for veterans of the Vietnam War was only 4.8% in 1987, compared to the  6.2% rate for the rest of America.

chapters from every state was known as *Storming the Hill*.

We will assemble at 1100, Monday, 1 May, at Hawaii's Plantation Village, the Outdoor Museum of Hawaii's Cultural History, 94-695 Waipahu Street, Waipahu.

This will be a fascinating tour of a bygone era. Step back in time to when 'sugar was King' and experience the real Hawaii. Hawaii's Plantation Village is the perfect location for keiki, family and all ages to explore a living history museum and botanical garden. A visit opens a door to a time of true hospitality and cultural sharing that sprung from Hawaii's plantation life.


The Village tells the story of life on Hawaii's sugar plantations (circa 1850-1950) and is composed of a museum and restored build-

ings and replicas of plantation structures, including houses of various ethnic groups and community buildings such as the plantation store, infirmary, bathhouse and manager's office. We share the story of Hawaii's many cultures: including Hawaiian, Chinese, Japanese, Filipino, Korean, Okinawan, Portuguese and Puerto Rican.

Located in historic Waipahu town, local guides take you on a journey back to the early 1900s where you can experience more than 30 authentic plantation hvo-mes and structures featuring personal artifacts, clothing, furniture and art placed in their original settings. Unusual plants brought from China, Portugal, Japan, Puerto Rico, Korea, Okinawa, Polynesia and the Philippines by immigrants from their native lands provide delicious fruit samples during the tour. This "must-see" attrac-

tion is located in historic Waipahu town, just down the street from Waikale Shopping Outlets.

After our tour, which will end at 1300, we will meet at the nearby Highway Inn Restaurant, 94-830 Moloalo Street in Waipahu. There is plenty of free parking in front of the restaurant.

Our chapter President, **Fred Staedel**, hopes that we have an impressive turnout for our tour and luncheon. 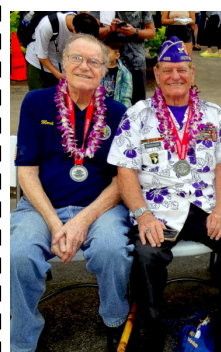
