WE SALUTE THE ARMY!!

Approximately 8,000 soldiers from the 25th Infantry Division have been alerted for a twelve month deployment to Iraq and Afghanistan early next year. "The Tropic Lightning Division is proud to have been selected for these challenging, diverse missions in our nation's global war on terrorism," said Major General Eric T. Olson, Commander, 25th Infantry Division (Light) and U.S. Army Hawaii. "Whether in the mountains of Afghanistan or the deserts of Iraq, the Soldiers of the America's Pacific Division are proud and ready and eager to show our army and our nation that we are true to our motto, 'Ready to strike! Anywhere, anytime!'"

About 350 Hawaii based Army reservists with the 411th Engineer Battalion have also been alerted to possible deployment to Iraq next year. It will be the first combat deployment since World War II for the 540 soldier battalion, which also has companies in Alaska and Guam.

The Hawaii Army Museum Society recently honored chapter member General Fred C. Weyand, former Army Chief of Staff, with its prestigious "Everyday Heroes" IHE Award. General Weyand, who served with distinction in World War II, the Korean War, and in Vietnam, in accepting the award expressed his opinion that in the aftermath of September 11, 2001, with the global proliferation of terrorist strikes by radical elements against America and its allies both at home and abroad, we have witnessed the start of World War III.

At our December Christmas Party, Hawaii Chapter will make a \$1000 donation to help provide emergency support for Army families in Hawaii. We care for our Army colleagues and with honor and pride salute the United States Army, past, present, and future.

"Personal information is valuable and should be safeguarded," said Claudia L. Bogard, DFAS Communications Director. "Don't provide your personal information to any website unless you know it can be trusted." Look-alike sites have recently frustrated myPay customers who have been confused by accidentally finding their way to a commercial site that is in no way affiliated with DFAS or the Department of Defense. MyPay is a secure, DFAS-operated web site that lets active-duty, National Guard and Reserve service members, civilian employees, and military retirees and annuitants take charge of their own pay accounts on line. Senator Landrieu to Champion SBP Campaign

Senator Mary Landrieu (D-LA) agreed to be the Senate champion of MOAA's and The Military Coalition's (TMC) fight to increase the Survivor Benefit Program (SBP) benefit to 55 percent after age 62. Sen. Landrieu is a strong supporter of military members and their families and is the sponsor of S. 401 which would raise the SBP benefit to 55 percent. MOAA is now working with Sen. Landrieu and Rep Jeff Miller (R-FL), the House SBP champion, to build an aggressive campaign aimed at getting funding authority in next year's Budget Resolution. To help in the fight, we need all members to continue sending letters to their legislators. A full campaign will begin after the 1st of January aimed at saturating our congressional delegation with letters and follow-up meetings.

Medicare Bill

The Medicare bill (S.1/H.R.1) is one of the last bills that Congress will act on in 2003. While everyone is not happy with all aspects of the bill, it does provide necessary changes that will affect all recipients and some that affect older military beneficiaries. AARP is actively supporting this bill.

Most importantly, the bill would stop a planned 4.5% cut in Medicare and TRICARE/TFL payments to doctors that will take place in January 2004 unless corrective legislation is passed before then. This bill would substitute a 1.5% payment increase, which is essential to keep doctors in Medicare and TRICARE and to attract more doctors to participate.

It also would provide relief for onerous Part B late enrollment penalties that many older military beneficiaries have had to pay to use TRICARE For Life. Further, it would stop capping Medicare physical therapy payments at \$1500 a year, as of January 2004. If you're a stroke victim, it doesn't take long to exceed that cap.

House OKs USCG Authorization Bill

The House has approved a \$7.1 billion USCG authorization measure (H.R. 2443) that increases the services manpower by 6,500 billets, establishes a USCG ROTC program and includes provisions to

Bring the Coast Guard more in line with other military branches.

North Carolina Congressman Walter B. Jones Jr., offered an amendment to the FY 2004 Coast Guard Authorization Act allowing the Commandant of the Coast Guard the authority to make recommendations, if asked, while testifying before Congress. This amendment would afford the Commandant of the Coast Guard the authority already available to the service chiefs of the Army, Navy, Air Force and Marine Corps.

Are Needed To Tell Their Stories

Military Historical Tours of Alexandria, Va. is searching for the survivors of Bataan and Corregidor for a special return-trip to the Philippines January 11-20, 2004. Dark Horse Media International will accompany this special tour back to Luzon Island to document the exploits and stories of the survivors. Family members of the veterans are also encouraged to participate in this unique experience. The first program will be developed as a pilot, to be aired in the spring of 2004 on the Discovery Channel.

TUG by Col Lou Torraca, USAF (Ret.)

On behalf of my fellow officers, thanks for your confidence in electing us to serve you again in 2004. We will continue to try and provide you with great programs every month!

Many thanks to Charmayne for a super program in Nov on MS Office. We have lots of talent in the TUG. Please, let Lois or Herman know if you are willing to do a program on your favorite subject.

I understand from Lois that we have had some interest in a program on how to use eBay. I did some research and found an article in Scot's newsletter that has a pretty extensive set of rules. It's pretty long, so I have only listed the 12 rules and some additional webpages for more info. He uses buying PCs as his theme, but as you will see, he indicates it applies in general to anything eBay offers. If you'd like the entire article, e-mail me and I'll send it to you.

Mastering eBay to Buy PCs:

I haven't bought a new notebook PC in over two years. I haven't bought a new desktop PC since 1998. Why? Three reasons. The first is that hardware has advanced far more rapidly than the operating systems and software that run on it. There's just far less reason to buy the latest, greatest personal computing hardware. The second reason is that, with desktop PCs, building them yourself is both fun, relatively easy, and you wind up with a much better product for about the same money.

The third reason has allowed me to keep pace with new notebook equipment: eBay. If you're knowledgeable about computer systems, buying and selling computers -- especially notebook computers -- on eBay can be a great way to save or make money. It's very possible to buy brand new, never used, never opened notebook PCs on eBay that have full warranties. And they'll cost hundreds of dollars less than the same models bought new from a traditional retail store or direct from the manufacturer.

Why? Because they're being sold by individuals or small businesses. That means there's an element of risk to the buyer, which brings the price down. If you become adept at figuring out who are the honest sellers in this game -- people you can trust to deal straight -- you can save yourself a pile of money. And if brand new isn't important to you -- you can grab a top-notch notebook PC that's a couple years old for just \$500 or less.

The 1GHz Compaq Evo 600c I'm typing this on cost me \$600. It was absolutely brand new with 640MB of RAM, a 20GB hard drive, a 14.1-inch LCD, dual pointing devices, Ethernet, and a pile of other stuff. It arrived sealed in its original box with all manuals, accessories, and discs. OK, so it's not the fastest CPU on the block. But I don't need any more than this. Even the least expensive new Compaq Evo 610c series notebook (which has an identical exterior but with faster CPUs) would have set me back \$1,700. It was a no-brainer.

By the way, computers aren't the only thing you can buy on eBay. I have a friend who has bought a BMW 5-series and a Range Rover on eBay. I've been in both and he's done well.

12 Rules for Buying Successfully on eBay.

- #1: Read the Auction Thoroughly (Before You Bid).
- #2: Read Feedback, and Take Negative Feedback Seriously.
- #3: Set a Final Price and Stick to It.
- #4: Research Your Seller!
- #5: Communicate Effectively and Politely.
- #6: Beware First-Time or Zero-Feedback Sellers.
- #7: Bid Shrewdly.
- #8: Don't Bid in Predictable Amounts.
- #10: Pay with Credit Card or PayPal.
- #11: Pay Promptly.
- #12: How to Leave Feedback.

Disabled Parking Enforcement Program

Once again Handicap Placard Holders are reminded to hang their placard from the rear view mirror so that it is clearly visible from the front and rear of the vehicle. You are not complying with the law, if you place the placard on your dash. If you are experiencing difficulty in hanging your placard from the rear view mirror, rig it with a piece of wire or string to assist in its hanging. Failing to hang your placard properly could result in your being cited, as some of the DPEP special police officers are in wheelchairs and unable to see placards placed on the dash. Consider this possible violation situation. You (not handicap), drive a handicap placard holder to the store. You park in a handicap stall, hang the placard, leave the vehicle and accompany your passenger to the store, assist as necessary, and return to the vehicle with your passenger. No problem. On the other hand, same situation except you drop off your passenger and proceed to park the vehicle in a handicap stall to await your passenger. Are you guilty of misusing the placard? You could be in that you are an able body person occupying a space that a handicap person is entitled to. After dropping off your passenger, you should park in a regular stall and when your passenger completes her business, drive up and pick her up. How do we distinguish the different situations? Easy, if you accompany your passenger parking in the handicap stall is okay. If you do not accompany your passenger, i.e., drop off. Arrange how you plan to meet your passenger when she completes her shopping, appointment, etc. Park your vehicle in a regular stall and pickup as previously arranged. Give it some thought. Reaching the proper solution is logical.

TAMC/TRICARE Matters

Tripler Army Medical Center (TAMC) TRICARE Hawaii Regional Beneficiary Advisory Council/Health Consumer Committee Meeting of 29 October advised that TAMC personnel are being tasked for deployment to Iraq and asked that those seeking treatment to be aware and to exercise patience and understanding during this period of heightened activity.

Those personnel contemplating changing from TRICARE PRIME to TRICARE STANDARD are encouraged to seek counsel before making the transition.

TRICARE On Line (TOL) is available for TRICARE PRIME and TRICARE PLUS patients enrolled in TAMC Primary Care Clinics and Schofield Barracks Clinics. Make your routine appointments on line through the Internet. Go to www.tricareonline.com and register.

The flu season usually peaks between January and March, so getting your shot in December or later can be beneficial in most years. Call your doctor or dial 1-800-232-2522 to learn more.

Finally, for those folks going on vacation that are taking medication, you are urged to take your prescription labeled containers (bottles) with you, so that in the event you run out of your medication, you can present your bottle(s) and the activity can provide you with a complementary issue. Lacking the bottle might necessitate your having to be enrolled in the issuing activity's Program thereby disenrolling you in the TAMC Program. Word to the wise include in your luggage all your medication needed for the trip in prescription labeled bottles.
