

## August Luncheon

Our guest speaker at our luncheon at the OVC on Friday, 18 August, is a contributing member of our chapter: Surviving Spouse Kathleen Ebey.



Kathy was born and raised in Aberdeen, SD, the town where the Northern Pacific trains and the Milwaukee trains intersected.

Her uncle was an engineer with the Milwaukee. We lived 2 blocks and half a corn field from the Milwaukee tracks and she would run out to watch him leave on his route to Mobridge. He would always blow the horn and all the employees on-board would wave at her.

Later in life, she and her husband Jack started riding AMTRAK. They went on every route, many of them more than once. Other people fly from Hawaii to their Mainland destinations. They flew from Hawaii to the West Coast and took AMTRAK to their destination, as far as Boston and New Orleans, and many places in between.

When our chapter went on the MOAA train ride about 16

months ago she realized how much she missed trains. So she became a volunteer there in March '22.

One of Kathy's first tasks was to organize lots of paperwork, much of it having to do with Drew Pearson's Friendship Train in 1947 and France's "Merci" train in 1949. As she learned more about these two trains, She learned that Hawaii received a special rail car from France in 1949.

The Hawaiian Railway Society (HRS) does have the French box-car from the Merci train, and it is in the process of being restored to its original beauty

Kathy continues to volunteer with HRS and is currently doing "landscaping" tasks in the visitor areas

Eighteen chapter members and guests really enjoyed this interesting and uncommon topic eloquently delivered by Kathy.

## NOTICE

While our Bylaws only require membership vote on election to the Board, with only Board approval to decide on the other matters, the Board feels that these other issues are important enough to ask for membership approval at the Annual General Membership Meeting on 17 Nov. The five (5) items to be voted on are:

- The election of three (3) board members (Mike Fricano, Wes Fong, and John Kim, whose terms are expiring have agreed to serve another term; however, other nominations will be accepted at the meeting)

- Bylaw changes, one specifying the chapter membership process, and one allowing spouses to be Regular members of the chapter without being members of MOAA National:

1. Change ARTICLE IV — MEMBERSHIP, Section 1:

Added sentence: **Those eligible and desiring to be Regular members must apply for membership (provide a completed Membership Application Form) and pay dues in accordance with Article VI.**

2. Change ARTICLE IV — MEMBERSHIP, Section 5:

Old verbiage: Section 5. Regular members are required to hold and maintain membership in national MOAA.

New verbiage: Section 5. Regular members **who are eligible to be members of national MOAA** are required to hold and maintain membership in national MOAA.

- If the Bylaws change to Article IV, Section 5 is approved, then the cost of spouse membership dues is the same as the cost of Regular membership dues

- Continue with every-other-month chapter meetings/activities (due to waning participation) or revert back to every month

- A change to the chapter's logo design, removing the existing rainbow



## MEDICARE Open Enrollment

Medicare Open Enrollment starts October 15! Even if you're happy with your current plan, **it's important to check for any changes next year** and compare your coverage with other available options. You may even save money, find better coverage, or both!

You can visit [Medicare.gov](https://www.medicare.gov) to preview coverage options before Open Enrollment.

**Create or log into your secure Medicare account** to:

- Check details on how your current coverage is changing next year.
- Compare benefits and costs in your current plan to other options available in your area.
- Build your prescription drug list and local pharmacies to help you compare drug costs.

Check prices based on any help you get with prescription drug costs.

**Remember:** When comparing your choices, look at the estimated "Yearly Drug & Premium Cost." A plan with the lowest monthly premium may not always offer you the lowest total cost.



## Social Security Announces 3.2% Benefit Increase for 2024

Social Security and Supplemental Security Income (SSI) benefits for more than 71 million Americans will increase 3.2 percent in 2024, the Social Security Administration announced today. On average, Social Security retirement benefits will increase by more than \$50 per month starting in January.

More than 66 million Social Security beneficiaries will see the 3.2 percent cost-of-living adjustment (COLA) beginning in January 2024. Increased payments to approximately 7.5 million people receiving SSI will begin on December 29, 2023. (Note: some people receive both Social Security and SSI benefits).

“Social Security and SSI benefits will increase in 2024, and this will help millions of people keep up with expenses,” said Kilolo Kijakazi, Acting Commissioner of Social Security.

Some other adjustments that take effect in January of each year are based on the increase in average wages. Based on that increase, the maximum amount of earnings subject to the Social Security tax (taxable maximum) will increase to \$168,600 from \$160,200.

Social Security begins notifying people about their new benefit amount by mail starting in early December. Individuals who have a personal [my Social Security](#) account can view their COLA notice online, which is secure, easy, and faster than receiving a letter in the mail. People can set up text or email alerts when there is a new message--such as their COLA notice--waiting for them in [my Social Security](#).

People will need to have a [my Social Security](#) account by November 14 to see their COLA notice online. To get started, visit [www.ssa.gov/myaccount](http://www.ssa.gov/myaccount).

Information about Medicare changes for 2024 will be available at [www.medicare.gov](http://www.medicare.gov). For Social Security beneficiaries enrolled in Medicare, their

new 2024 benefit amount will be available in December through the mailed COLA notice and [my Social Security's](#) Message Center.

The Social Security Act provides for how the COLA is calculated. The Social Security Act ties the annual COLA to the increase in the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) as determined by the Department of Labor’s Bureau of Labor Statistics.

## Chaplain's Corner

Our world and our nation are changing in alarming directions and it is natural to be anxious and fearful. Social norms seem to be changing, political movements appear to be threatening, and our world appears to be on a path of turning upside-down. Such changes often appear threatening. So, what action can we all individually take to quell such anxiety? What is the answer? The Holy Bible once again gives us that answer: “But if we hope for what we do not see, we wait for it with patience.” (Romans 8:25)

We can find patience through prayer. When we pray for an answer and answers don't rapidly appear, patience is required to see and understand the answer. And then often there is the additional anxiety and frustration that can come from friends and even family members. Again, the Bible gives us an answer of what other mindful mental attributes we can adopt when coupled with patience that will give us peace and compassion with others who seem to give us such mental discord: “Therefore, as God's chosen people, holy and dearly loved, clothe yourselves with compassion, kindness, and patience.” (Colossians 3:12).

## FEDVIP Open Season for Military and Retiree Health Insurance

Every year from mid-November to mid-December, all federal health insurance plans offer open enrollment, also known as open season. This open season gives beneficiaries enrolled in these insurance plans a chance to make changes to their annual contracted coverage.

The 2023 open season for coverage in 2024 runs from Nov. 13 – Dec. 11.

During open season military retirees, active duty family members and those enrolled in Tricare Reserve Select may purchase or make changes to their dental and vision insurance, with the Federal Employee Vision Insurance Program (FEDVIP).

FEDVIP allows military retirees to purchase dental coverage and active-duty families and those enrolled in Tricare Reserve Select to purchase vision coverage.

Outside of open season, you can make health insurance changes only if you experience a qualifying life event such as moving to a new area or changing your number of dependents.

In 2024, FEDVIP enrollees will see increases or decreases in premiums for dental and vision insurance from the current year's rates depending on their chosen plans.

If you're currently enrolled in a FEDVIP plan and don't want to make any changes to your coverage, there is nothing you need to do to remain in your current plan. Your coverage will remain the same in the upcoming year.
