TRICARE for LIFE Hospitals and Doctors

Question: What doctors and which hospitals in Hawaii will participate in TFL?

Answer: For those going to participate in the TriCare for Life program, have you checked out if your doctor (s) and hospital are participants in this program? All hospitals in Honolulu, EXCEPT Kaiser Medical Center, are participants in the TriCare for Life program. If you are a member of a Kaiser Health/Medical Plan then you must continue paying Kaiser supplemental health/medical plan premiums or switch to a different doctor(s)/ hospital that IS a participant of the TriCare for Life program.

Member of the Month Hawaii Chapter recognizes Captain Lawrence Kelley USN

"An Officer and a gentleman are two word that describe Captain Lawrence Kelley." His 30 years of service in the Navy include: WW II service in New Guinea and the Philippines with landing ships and PT boats; a summer in Tsingtao, China in 1947; operations officer on board the 7th Fleet flagship based in Yokosuka, Japan; skipper of three ships; assistant professor of NROTC at Yale University; time in Vietnam with anti-infiltration forces; in charge of Navy Special Warface in the Pentagon; and 31 months of service in Korea.

In 1975 Kelley became the director of operations for Seaflight, an interisland hydrofoil ferry. After two and a

half years with Seaflight, he joined the crew of the SS Independence as 3rd officer in 1980. He became Captain in



1983 and enjoyed an eight year stint at the helm of the glamorous vessel. Nightly he dined with luminaries such as Cary Grant, Ginger Rogers, Rosemary Clooney, Melveen Lead, Loyal Garner, and Esther Williams.

Now in retirement, Captain Kelley continues his service to others as a Lanakila Meals On Wheels volunteer meal deliverer. Twice a week he visits his 27 seniors on his Pacific Heights and Kuhuku Meals On Wheels routes, bringing them sustenance of the body and spirti. Captain Kelley comments of his charges, "I think of them as family and I really look forward to my weekly visits with them."

Larry and the lovely Florence have been married for forty-four years, with one son Kevin. The Kelley's reside in Kaneohe.

TRICARE for Life "will be" Fully Funded

President Bush signed the FY2001 Supplemental Appropriations Act, which provides for funding shortfalls in a variety of areas for the current fiscal year including \$1.6 billion for TRICARE Senior Pharmacy program and other health care 2001 needs. TRICARE for Life will be funded by the FY2002 Appropriations Act. Congress already has approved budget "headroom" for TFL in the FY2002 Budget Resolution. Should the Appropriations Act not become law by October 1, which is normal for the Congress, the House and Senate Appropriations Committees have stated that, since TFL authority is already on the lawbooks, it will be funded under the terms of the continuing resolution. Hence, "there is no remaining doubt" that Congress will approve full funding for TFL by its start date, October 1.

Concurrent Receipt

There are two bills working their way through Congress - HR 303 and S 170 - which if passed would authorize full concurrent receipt of military retired pay and disability compensation. Both bills have many co-sponsors including all four of the Hawaii delegation. However, even if passed, there is no money in any appropriation bill at this time. Pressure must be kept on the Congress if this measure is to be successful.

In a related area of interest, apparently the administration's effort to force retirees to choose between healthcare provided by DOD and the VA programs is dead.

Bud Day's "Win" Vacated by Appellate Court

The United States Court of Appeals set aside an earlier ruling that upheld Colonel Bud Day's (USAF-Ret) Class Act Group lawsuit and ordered a rehearing by the full Court of Appeals. The earlier decision by a three-judge panel of the same court found that military retirees who entered service before June 7, 1956, had indeed been promised free lifetime health care. If the ruling had stood, it would have required the government to pay three million retirees, widows and dependents up to \$10,000 apiece. The new ruling directs the parties to refile briefs by September 14, 2001, to include three main questions:

- (1) Whether the promises of free lifetime health care are enforceable under the law;
- (2) To what extent Congress has fulfilled such promises through the military health care system; and
- (3) What relevance Congress' recent enactment TRI-CARE For Life has to this court case. A rehearing date has not been set.

Survivor Benefits Program

Improvements to the Survivor Benefits Program are contained in HR 548 and S 145. Both would restore the annuity to 55% in three steps: to 40% immediately, to 45% in 2004, and 55% no later than 2011. Senator Inouye is a co-sponsor of S 145, but none of the rest of the delegation have stepped up to the plate.

In related bills, that would move up the implementation of the 30 year paid-up date for SRB from 2008 to 2002, none of the Hawaii delegation is a sponsor.

The decisions on these bills will be coming soon after Labor Day when Congress goes back in session. Now is the time to write or call our Representatives and Senators. A short handwritten note is most effective. Addresses and phone numbers are contained on page 31 of our 2001 Membership Directory. Please make contact soon. Action will get results.

VA Benefit Forms on the Internet

If you haven't already enrolled in VA health care, you should do so now. Veterans regardless of disability or financial status should be enrolled with the VA. You can now file for some VA benefits via the Internet. Currently VA has four standard forms available for electronic filing. They are:

- * Form 10-10EZ (used to enroll in VA health care)
- * Form 21-526 (first filing for disability compensation on a VA pension)
- * Form 28-1900 (disabled veterans applying for vocational rehabilitation)
- * Form 22-8979 (verify enrollment in school under the Montgomery GI Bill)

TRICARE for Life Information

Over the past several weeks the TRICARE Management Activity mailed more than 1.5 million information packets about new TRICARE for Life (TFL) benefits to Medicare-eligible retirees and their families. The package includes TFL coverage and cost details and a wallet-sized card for beneficiaries to show providers. Potential beneficiaries who do not receive a package should check their records in the Defense Enrollment Eligibility Reporting System. More information will be provided at Schofield on Sept. 15.

TRICARE Hawaii Regional Beneficiary Advisory Council/Health Center Report By Don Hutchinson

The TRICARE Hawaii Regional Beneficiary Advisory Council/Health Consumer Committee met on 25 July 2001. Work is continuing at all levels of DoD for the implementation of TRICARE for Life on 1 October 2001. It is available to all uniformed services beneficiaries who are Medicare eligible and have Medicare Part B coverage. TRICARE for Life acts as a secondary payer to Medicare and claims are filed automatically. There is no cost for TRICARE for Life. Your only cost is for Medicare Part B coverage, currently \$50 a month, which is deducted from your monthly Social Security check. After 1 October 2001, you will no longer need a Medicare supplemental insurance policy such as TROA's MediPlus. Do not cancel you supplemental insurance before TRICARE for Life becomes effective. Eligible personnel overseas will not be able to use Medicare, but will have Tricare available with the same deductibles and co-payments as the under age 65 in the US. You must have a valid ID card and up to date information in DEERS. Anyone who is currently using a military medical facility is current in DEERS or you would not be treated. All personnel currently enrolled will soon receive a mailout from DEERS. TRICARE Plus

is a new military treatment facility (MTF) primary care enrollment program to be offered at selected local MTFs. Tripler will offer the program with an implementation date of 3 January 2002. Enrollment is limited by capacity. First priority for enrollment will go to those currently in the Tripler Care Silver program, numbering about 3,000. The program will be re-evalutated about 1 Oct 2002 for possible additional senior enrollees. The current Care Silver enrollees should find services to be about the same under Tricare Plus.

Several briefings on Tricare for Life and Tricare Plus will be held with dates and times published in various newspapers. Questions about both programs may be directed to the Tripler Managed Care Division at 433-7986 (Terri Cloud) or 433-7073 (Maj. Sanders) Information is also available at www. tricare.osd.mil/plus/ .When you pick up a prescription at the Tripler pharmacy, the computer will automatically check your DEERS enrollment. If you are not enrolled, you can still get your prescription and will be told of the need to update. Visit your military personnel section to do the update. The National Mail Order Pharmacy (NMOP) has a broader formulary than Tripler. Costco and

Safeway pharmacies have been added to Longs as participants in the Tricare Pharmacy programs. NMOP can be used overseas if the retiree has an APO, FPO or Embassy mail address available. For NMOP information, visit www.merck-medco. com on the web or call 800-903-4680.

Work continues on the transition from DEERS to the National Enrollment Database (NED). It will take several months, as the data from Hawaii is mailed to the mainland for the input to NED. All veterans should be enrolled with the VA, but only be enrolled with one Primary Care Manager(PCM), either in the DoD medical system or the VA. It is recommended that all veterans with a VA disability rating of 70% or higher should use the VA for primary medical care, as the VA offers long term care if needed.

You will complete a nine-item questionnaire which will give you a personal summary which you can then print out. Your questionnaire answers are "Confidential" for your use. MEDIPLUS STATUS FROM TROA

TRICARE For Life (TFL) begins October 1, 2001, and will require some personal decisions from current MEDIPLUS Medicare Supplement holders about when to cancel their supplements. TFL will almost entirely duplicate the benefits provided under MEDIPLUS Medicare Supplements. Therefore, TROA fully expects and recommends that our members stop paying for their Medicare Supplement insurance and move to premium-free TFL, however, not before the October 1, 2001 implementation date.

Because TROA expects numerous members to cancel MEDIPLUS Medicare Supplements and use TFL, it eventually will become necessary to cancel any remaining MEDIPLUS Medicare Supplements. This is because there will be too few policyholders left to run a financially stable program without at least doubling or tripling premiums to cover fixed costs. It would be unfair to continue the TROA program when there will

be less costly supplements available through other sources. What to do will was decided by our Board of Directors at their July quarterly meeting, and TROA will be providing this information in a letter that is being sent in August.

TROA began sending in mid-August every MEDIPLUS Medicare Supplement certificate holder a letter of instruction and checklist of things to do to get ready for TFL. We will have a simplified MEDIPLUS cancellation procedure in place by then which can be accomplished by phone, and that procedure will also be included in the August letter. There will be plenty of time to complete the required actions in time for TFL's October 1 implementation date. Therefore, please read the letter that you will receive in August that will address your concerns. TROA is working on updating our website insurance section to reflect this information also in August and placing information in the September TROA

If you would like to cancel your coverage effective 10/1/01 today, please call 1

(800) 247-2192 and listen to the greeting. Then dial 6 to cancel your MEDIPLUS coverage due to TFL. Then you will need to listen to the prompts. You will need your MEDIPLUS certificate number.

If your recent premium notice was for a period of coverage that extends beyond the October 1, 2001, implementation of TRI-CARE For Life, you may send the full amount indicated on your premium notice and your MEDIPLUS coverage will remain active. Or, if you know that you do not want to continue Medicare supplemental coverage after October 1, 2001, you may remit only the amount of premium required to pay for coverage up to that date. If you have questions regarding the amount of premium due, please call our insurance office at 1-800-247-2192. PLEASE NOTE - The MEDIPLUS TRI-CARE Supplements are unchanged. If a Medicare-eligible certificate holder has a spouse who is still TRICARE eligible (under age 65), the certificate holder can cancel their MEDIPLUS Medicare Supplement and leave the spouse's MEDIPLUS TRICARE Supplement active and unchanged. There will be no change in TROA's MEDIPLUS TRICARE Supplement program.
